Move-In/Move-Out. The established MOVE-IN for this EVENT may begin no earlier than 3pm on Tues 06.22.2021 and the established MOVE-OUT must be complete no later than 9:00am on Tues 06.29.2021.

DOGS ELIGIBLE TO ENTER

These trials are open to all dogs (June 23) and to all Dalmatians (June 24) fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word “dog” is used in these regulations it includes both sexes. Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog’s physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under four months of age are strictly prohibited from the trial grounds.

MEASURING AND HEIGHT CARD INFORMATION

All dogs without a permanent or temporary height card will have to be measured by the judge before running. However, if a **Volunteer Measuring Official (VMO)** or an **Agility Field Rep** is present; ALL dogs without a valid Jump Height Card/Form must be measured at some time during the trial or cluster of trials. Height cards are not required to be submitted to the trial secretary, however, all exhibitors should carry the original AKC official jump height card with them to each trial in order to present the card upon request. When filling out the entry form, there is a section on the form for exhibitors to designate whether your dog needs to be officially measured. Please check the appropriate box so that the Trial Secretary knows whether to include your dog on the *Dogs To Be Measured List*. It is no longer required that you submit a copy of your dog’s jump height card with your entry form or show it during day of show check-in.

OBSTACLES AND RING CONDITIONS

Obstacles will meet the specifications for obstacles in the current edition of the Regulations for Agility Trials. All classes will take place indoors on GGT™ Fiber Footing installed over GGT™ Butterfly Mats. Ring size will be 100' x 110'. Electronic timers will be used. Equipment will be provided by DASH (Dog Agility Show Services – St. Louis).

WAIT LIST FOR WITHDRAWN ENTRIES

DCA is offering a wait list to fill openings created by withdrawn entries after the trial's closing date/time. A maximum of 20 entries will be placed on the club's wait list per trial. All entries, including waitlisted entries, *must be received by the Trial Secretary prior to closing Wed., 6/2/2021, at 5PM EDT.* Any entries wishing to be withdrawn that are requested by Monday, June 14, 2021, 6PM EDT will be replaced by a waitlisted entry *if any are available.* If a withdrawn entry is replaced by a wait-listed entry, a full refund will be issued for the withdrawn entry. Any waitlisted entry that does not move off the wait list into the trial by 6/23/2021 will receive a full refund. (We will destroy the entry and the check.)

COURSE WALK-THROUGHS AND WARM-UP INFORMATION

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. Handlers with multiple dogs, at events with multiple rings may request to walk with a height group other than the one their dog is entered in if a conflict is imminent.

A warm-up area, consisting of a regulation agility jump, may be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

NOTICE TO EXHIBITORS

- **THE AGILITY TRIAL COMMITTEE, THE DALMATIAN CLUB OF AMERICA, INC. SHOW EVENT COMMITTEE, AND THE SPECIALTY STEERING COMMITTEE CHAIRMAN** may make and enforce any rules they deem necessary to ensure the continuity of the Agility Trial and the goodwill of the landowner. Any disciplinary event hearing, rule violation, complaint, or charges will be resolved by the Dalmatian Club of America, Inc. National Specialty Show Event Committee. The Show Event Committee members are Toni Linstedt, Chair, Dr. Charles Garvin, Paula Olcott, SarahAnne Vancleeve, Meg Hennessey and John Cramer.
- Exhibitors may wear shirts or insignia of their training group if they wish.
- Entry fees less a \$10 admin fee per trial day for bitches entered in agility that come in season after entries close shall be refunded. Bitches in season will not be admitted to the trial.
- Entry fee will not be refunded in the event that a dog is absent, disqualified, excused by the judge, or barred from competition by action of the Show Event Committee.
- No entries will be accepted by phone or fax
- Changes, additions, or corrections to entry forms must be received in writing prior to the close of entries or as indicated in this document for move-ups. Those received by telephone are not acceptable.
- Please notify Secretary of any change of address.
- No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an act of god, public emergency, act of a public enemy, strikes, or any other cause beyond the control of the Club or the Secretary.
- No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance.
- **Illegible entries** will not be processed and will be returned to the exhibitor. Returned/Re-deposited/Post-dated checks do not constitute a valid entry.
- All dogs must be kept on leash except when in the Agility ring.
- No dogs allowed in rings before or after show hours. Dogs are allowed in rings only during judging hours.
- **The show-giving club, the Show Secretary, the landowners, or National Equestrian Center assume no responsibility for any loss, damage, or injury sustained by the exhibitors, handlers, nor to any of**

their dogs or property and further assume no responsibility for injury to children.

- The show-giving club assumes no responsibility for the welfare of children and further expects exhibitors and spectators to keep their children under strict control.
- No dogs allowed in rest rooms, and no washing of animal food containers in rest rooms. Exercise dogs in designated areas only.
- **No videotaping or photography during the events for resale is permitted without Dalmatian Club of America, Inc. approval.**
- **Please be advised:** When exhibitors/handlers bring a dog to the podium for a win/placement photo, they are establishing a de facto contract with the show photographer to purchase that photo.
- **No baby strollers are allowed near the ring during show hours.**
- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
- The trial secretary will add a \$25 collection fee to the amount of each returned/re-deposited check.
- **This club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.**
- **EXHIBITORS & GUESTS: No one is permitted anywhere that is marked "Employees Only" and/or "No Admittance." No firearms allowed on the National Equestrian Center property. Violators will be reported to the AKC. No Smoking (including electronic cigarettes) in the Buildings. No push pins, nails or any type of things going into the walls. No adhesive should be used to affix a sign to a wall. Masking tape or command strips may be used.**
- **UNLOADING/PARKING: No driving on grass areas.**

CLASS CHANGES EFFECTIVE JANUARY 1, 2020

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend Multiple Jump Heights Within the Same Trial Day: Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. For example, the same dog may now be entered in Regular FAST and/or T2B to finish up those titles while also entered in Preferred Master STD/JWW to start working towards their PACH at the lower height. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day. Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day. **A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.** When calculating entry fees, treat multiple entry forms for the same dog as if only one form had been filled out. In other words, the 1st run entry fee is only paid once per day, per dog, even if that dog's runs have been submitted on multiple entry forms.

Entering For Exhibition Only (FEO): As of January 1, 2020, For Exhibition Only may be offered at the option of the host club. FEO will be offered on a one-year pilot basis in order to give AKC time to evaluate its impact. FEO will allow exhibitors to work with their dogs in a trial environment. FEO is only allowed in the Time 2 Beat and FAST classes. FEO will be of value to new exhibitors or exhibitors that are having difficulty with a specific obstacle and/or ring environment. Competitors must enter in T2B and/or FAST. Participation in FEO is non-qualifying. FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B and/or FAST) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show. Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed. Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the dog

is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.

The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (ex. when checking in at the gate board). Toys are allowed in the ring. Toys must be non-audible.

Toys may not leave the handler's hand. Toys that roll freely cannot be used. Food/treats are not allowed in the ring. FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh verbal and /or physical corrections shall not be tolerated. Any determination of harshness by the judge shall be immediately whistled and the handler will be dismissed from the ring.

A judge must monitor the entire run. Judges can stop a run at any time.

Fix and Go On (FNG): As of January 1, 2020, Fix and Go On will be offered on a one-year pilot basis in order to give AKC time to evaluate its impact. FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score. Fix and Go On is not pre-entered; rather, it occurs during the course of the run.

AWARDS

Qualifying score required for all prizes. "Dog" means either sex. Trophies not awarded become the property of the Dalmatian Club of America, Inc. Unless specified, all trophies must be claimed the day of the show. None will be mailed, except for those trophies that have been specified herein. Dogs entered in the **Preferred** classes **must** compete at the required jump height and **may not** compete in a jump height division **higher or lower** than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or *back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.
