Directions to Test Site

Take Exit 278 from I-5 (Aurora/Donald Exit). From I-5, go west following the State Park signs. Turn right on Cascade Road and follow it to Champoeg Road. Road takes left at Champoeg Road, with Park on the right. Park is 8 miles from I-5.

If you are not camped on site, you need a \$5 parking pass from the kiosk at the museum parking lot. Then proceed downhill towards the camping loops. Just past Camping Loop A and to your left, you will see the RV Group Campsite and meeting hall. Follow the one-way loop to access parking for the building.
