

DOGS ELIGIBLE TO ENTER

This trial is open to all dogs SIX (6) months or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Where the word "dog" is used in these regulations it includes both sexes.

Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, the dog displays no sign of physical discomfort and can safely complete the search. Deaf and blind dogs are allowed to enter. Females in season may not participate, aggressive dogs, or dogs suffering from an injury, or illness which may affect the dog's physical or mental performance may not participate. No dog shall compete if it is sutured, bandaged, or has any visible wounds.

STAGING AREA, HANDLER'S BRIEFING, AND WARM-UP INFORMATION

Staging Area will be out of view of search area(s).

The Handler's Briefing will take place in view of the search area prior to the start of each class, after the hide(s) have been set and after the Demo Dog has run. In the Handler's Briefing the judge will explain if there is an off-leash option, number of hides, maximum height of hides and maximum time for the search. NO DOGS are to be present during the Handler's Briefing.

A warm-up area will be available consisting of ONE marked container of each odor being tested at the trial and may also consist of blanks containers. Exhibitors should limit their warm-up to (2) two minutes or less. The warm-up area is to be used exclusively for warming up the handler-dog team prior to their run. The warm-up area is not for training or relieving of the dog.

SEARCH AREA AND RING CONDITIONS

Search areas may be of any shape and of the size specified in the Regulations for each class.

Search Area Conditions. Searches may be indoors, on cement, matted, carpeted, or tiled surfaces, or outdoors on grass, gravel, concrete, or asphalt surfaces. GNF is a horse event property; the search areas will be in and around horse stalls, arenas and barns. Trial will take place rain or shine.

ADDITIONAL SITE INFORMATION

Trial Site. It is not appropriate to visit the trial location prior to the trial date. Many search locations are real-life environments and such visits may risk the host losing opportunity to use the location in the future.

Possession of Odors and Training. Chapter 5. Section 26 of the Scent Work Regulations state "No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area".

Spectator Area. Spectators are encouraged. Any person not handling a dog in the current class, or any person who has already completed their run-in the class may choose to watch the search from the spectator area. Handlers may not watch other exhibitors from their class prior to their run except in the case of Handler Discrimination classes. No one outside the search area may assist the handler or disclose the location of the hide.

Spectators who intentional or unintentionally give aid to a team may be asked to leave the area by the judge. Spectators are forbidden to discuss details of the search with handlers who have not run.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies

DCA HOTEL POLICY: Any exhibitor who allows his/her dogs to be loose & unattended in a room or to damage hotel property & does not immediately contact the hotel management to make proper restitution will be subject to a Show Event Committee action which could result in the loss of AKC privileges. If it is determined by the Committee hearing that rules are being neglected & destruction and/or misuse of property is taking place, the Committee has the authority to correct the problem or seek AKC suspension.

ONLY DOGS THAT ARE ELIGIBLE to be shown under the *American Kennel Club Rules* shall be allowed within the Show Precincts. PUPPIES UNDER FOUR (4) MONTHS ARE NOT ALLOWED on the Show Precincts or at any events associated with or held in conjunction with the DCA Specialty Show. The Show Event Committee has the authority to correct a violation of this AKC Rule.

RV PARKING

RV Parking is managed by the GNFA. Advance reservations are required. Make reservations through the GNFA website at https://sitereservations.com/ Daily rental rates are \$45 for 30 AMP or \$55 for 50 AMP. All sites come with water and sewer or a free honey wagon service provided through the fairgrounds. NOTE: You do not get to pick your location with regular RV parking.

Upgraded PREMIUM RV sites are available, choose your exact location close to all the action for a one time up charge plus the daily rental fee from the fairgrounds. Your spot will be marked with your name or kennel name on an adorable garden flag with the DCA 2024 National logo or performance logo. A one time up charge of \$30 or \$75 plus the daily rental rate to the fairgrounds is required.
