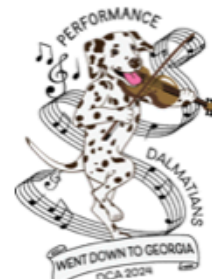

If there are fewer RDX and RD entries, more CC entries may be accepted, as time/temperature allows, according to Chapter 1, Section 13 of the DCA Road Trial Regulations.

**CLASS PLACEMENTS:** First place prizes will be a 10" glass art piece with the DCA Logo. #### **SPECIAL PERFORMANCE AWARD - THE TRIATHLETE CHALLENGE**

If you and your dog are a multi-tasking team, set your sights on the TRIATHLETE CHALLENGE, a special award given to EACH Dalmatian/handler team that earns a qualifying leg or passing score in three (3) or more performance/companion venue during the National Specialty. The eligible events are: Tracking, Road Trial - CC, RD, RDX classes; Agility - all titling classes; Obedience; Rally - all titling classes, Barn Hunt - all titling classes; Scent Work - all titling classes and Fast CAT. Only one score or performance in each venue will count towards this award, and the performance must be at the titling level, although the dog/handler team may already have earned the relevant title. If your dog can hock, heel, sniff, run, or jump, just pick your venues and go for the challenge! All Paperwork MUST BE turned in on time. **No awards will be mailed.**

**Be responsible and clean up after your dog.**

By signing the entry form for this test, you agree to pick up after your own dog. It is actually a bench show offense to walk off without picking up.



**TRIAL INFORMATION  
DOGS ELIGIBLE TO ENTER**

As used in these Regulations, the word "dog" refers to either sex but only to Dalmatians that are purebred and eligible for registration in the American Kennel Club studbook or an AKC limited registration. An eligible unregistered dog for which the American Kennel Club has issued a PAL (ILP) number may also be entered. Any dog that is registered in the official registry of another country as a purebred Dalmatian or that holds a United Kennel Club registration may also be entered in a Dalmatian Club of America Road Trial. All Dalmatians entered in a Dalmatian Club of America Road Trial as described in these Regulations will be eligible for any prizes or titles offered at said trial.

**CLASSES OFFERED**



**COACHING CERTIFICATE/COACHING CERTIFICATE CARRIAGE TEST:** Open to purebred Dalmatians not less than six months of age, regardless of previous titles earned, as described in the Road Trial Regulations, Chapter 7, Section 1.

**12.5 MILE ROAD DOG CLASS:**

**ROAD DOG - A:** Open to any Dalmatian not less than 12 months of age on the day of the Trial that has not yet earned the Road Dog Title & is being handled by an exhibitor who has not previously qualified any dog for the RD title at any Road Trial.

**ROAD DOG - B:** Open to any Dalmatian not less than 12 months of age on the day of the Trial that: 1) has already earned the title RD or RDX, and/or 2) is being handled by an exhibitor who has previously qualified a dog for the RD or RDX title. A dog that has previously earned an RD or RDX may continue to compete in this class, but only if all available Time slots have not already been filled with dogs that have not yet earned an RD title.

**25 MILE ROAD DOG EXCELLENT CLASS:**

**ROAD DOG EXCELLENT - A:** Open to any Dalmatian not less than 18 months of age on the day of the Trial that has earned the title RD, but has not yet earned the title RDX, and is being handled by an exhibitor who has not previously qualified any dog for the RDX title.

**ROAD DOG EXCELLENT - B:** Open to any Dalmatian not less than 18 months of age on the day of the Trial that has earned the title RD and 1) has already earned the title RDX and/or 2) is being handled by an exhibitor who has previously qualified a dog for the RDX title. A dog that has previously earned an RDX may continue to compete in this class, but only if all available Time slots have not already been filled with dogs that have not yet earned an RDX title.

## HORSE RENTAL/BOARDING INFORMATION

**Horse rental for RD** - 12.5 miles - \$300 includes horse and rider familiarization on June 13, 2024 and the Road Trial on June 14, 2024.

**Horse rental for RDX** - 25 miles, 2 horses - \$600 includes horse and rider familiarization ride on June 13, 2024 and the Road Trial on June 14, 2024.

**Horse rental for CC:** A horse & carriage with driver will be available for rental for CC exhibitors at a cost of \$75 per team.

**Rental horses are limited & will be available for reservation on a "first come, first served" basis after the closing date of May 22, 2024.**

*Please be very honest about your riding experience when you reserve your horse. You owe it to your dog, your horse & yourself to secure a suitable mount. The Dalmatian Club of America, Inc. does not contract with any supplier of rental horses & therefore makes no claim, warranty or assertions as to the safety or suitability of any rental horse. Riders that choose to rent a horse for the purpose of participation at any DCA Road Trial do so at their own risk. Riders are strongly encouraged to clarify & understand any terms of liability required by the supplier prior to the rental of any horse.*

Stalls are \$35/day for the first 2 days and \$5/day for additional days. Trailer parking is free.**

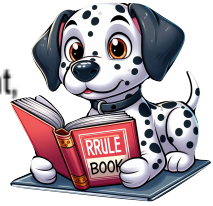
**NOTE: Horses brought onto the Georgia National Fairgrounds must have a current negative Coggins test less than 6 months (on date of arrival to stables) & health Certificate less than 20 days old (on date of arrival to stables). No Exceptions.**

Checks or Money Orders issued in US funds made payable to DCA **must arrive by 7:00 PM EST on May 15, 2024.** Express mail rental fees/signed releases **must include signature permitting them to be left at 100 Old Hickory Court, Longwood, FL 32750** without the recipient's signature.

**RETURNED CHECKS** do not constitute a valid rental fee payment and the rental will be forfeited to another participant.

**CANCELLATIONS:** The rental fee will not be refunded in the event that a dog is absent, disqualified, excused by the judge or barred from competition by action of the Show Event Committee.

## ATTENTION EXHIBITORS



- All dogs must be kept on leash except when actually competing in the Agility, Barn Hunt, Fast CATs, Obedience, Rally, Road Trial, Scent Work rings or fields.
- The show site will be made available to exhibitors, Thursday June 13, 2024
- No unentered dogs or puppies allowed in building per AKC guidelines.
- No working (practice) in rings before or after show hours. Dogs are allowed in rings only during judging hours and scheduled practice times.
- No dogs allowed in restrooms and no washing of animal food containers in restrooms. Bathing of dogs limited to bathing area.
- Pick up after your dogs and dispose in provided receptacles.
- **No videotaping or photography during the events for resale is permitted without the Dalmatian Club of America, Inc. approval.**
- **Please be advised:** when an exhibitor/handler brings a dog to the podium for a win/placement photo they are establishing a de facto contract with the show photographer to purchase that photo.
- **No baby strollers are allowed in the show site or hallways during show hours.**
- Unless otherwise specified, all trophies must be claimed the day of the show. **None will be mailed.** The club reserves the right to substitute a prize of equal or greater value.
- **Waiver of Rights** The club reserves the right to remove any animal in distress from a parked vehicle or crate, and all persons attending these dog events hereby waive any claim for damages against the clubs for such removal. **PLEASE NOTE: It is expressly understood that exhibitors or spectators alone are responsible for the behavior of their dogs and/or children. Any exhibitor or spectator whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior or whose equipment creates an impediment to the safe flow of traffic may, at the discretion of the Event Committee, be asked to leave the event site. In such cases, no refund of any fees paid will be made. The show-giving clubs, Georgia National Fairgrounds, show secretary, their agents, employees, etc., assume no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, or any of their dogs or property and further assume no responsibility for injury to children & further expect exhibitors and spectators to keep their children and dogs under strict control.**
- All AKC Rules and Regulations will be enforced by the Show Event Committee under AKC guidelines. Failure to comply with these rules will result in charges being brought before the Show Event Committee. **Any event hearing, disciplinary action, rule violations, complaints, or charges will be resolved by the Dalmatian Club of America, Inc. National Specialty Event Committee: John Cramer, Dr. Kelly Flannigan, Toni Linstedt, Karen Rowan & Michele Wrath.**
- Tent stakes may be used within/or on the Fairgrounds but must be approved by maintenance. This is to ensure you will not hit any utility lines.

- GNFA MECHANICAL EQUIPMENT POLICY: Skateboards, scooters, roller skates, hover boards, roller blades, and other similar mechanical equipment are prohibited within all property known as the Georgia National Fairgrounds & Agri-center. This policy will be strictly enforced.

Express mail entries must include signature permitting them to be left at the Secretary's address without the recipient's signature. Acknowledgements of entries will be made as soon as possible after entries have closed. Should such acknowledgement not be received by the exhibitor within a reasonable time, please notify the Road Trial Secretary at the address noted above, or telephone. TO BE ACCEPTABLE an entry must be submitted with required entry fee on an official Road Trial Entry Form. ENTRY FORM CHANGES, additions, correction & cancellations must be received in writing prior to the closing of entries.

CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS. There will be no refund for duplicate entries.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or the Road Trial Secretary.

**ROAD TRIAL REGULATIONS** - All competitors in the Road Trial will be required to read, voluntarily agree & sign a statement of release & waiver of liability prior to participation. Release forms will be available at the registration table at the Road Trial check-in. Exhibitors are responsible for reading & being familiar with them. No entry will be accepted which specifies any condition as to its acceptance. Entries must be made on an official Road Trial entry form or photocopy. The DCA, the Trial Chairman & the Trial Secretary assume no responsibility for correctness or incomplete information given on the entry form. Entry fees will not be refunded in the event that a dog is absent, lame, sick, disqualified by the judge, or barred from competition by action of the Road Trial Chairman or Secretary or because it had been entered incorrectly. Returned checks do not constitute a valid entry fee. The Secretary will add a collection fee to the amount of each returned check. Refunds for cancellations due to judge changes, overpayments or cancellations made prior to the close of entries will be processed after the trial.

No dogs will be allowed in the show area except those entered in the Road Trial or being used in an official capacity as designated by the Trial Committee. The DCA & the Trial Chairman are not responsible to furnish any service to notify or summon exhibitors who are late for assigned judging. Exhibitors responsible for the presence of their dogs at the start point at their assigned Time. Judges will not wait for an exhibitor holding up a class but may judge the exhibit at a later Time at their discretion. Appropriate riding attire, including ASTM Certified Helmets & riding boots or shoes with at least 1/2-inch heel are required. The Trial Committee reserves the right to determine a rider's ability before allowing him/her to compete in the road trial. Should it be determined that a rider might present a safety hazard to himself, his horse or the dogs he/she may be excluded from competition. In this case, the entry fee will be refunded. Maps of the course will be available. This course is suitable for mounted exhibitors. Driving competitors are responsible for assessing the course & making the decision as to whether or not the course is suitable for driving.

**ONLY DOGS THAT ARE ELIGIBLE** to be shown under the *American Kennel Club Rules* shall be allowed within the Show Precincts. PUPPIES UNDER FOUR (4) MONTHS ARE NOT ALLOWED on the Show Precincts or at any events associated with or held in conjunction with the DCA Specialty Show. The Show Event Committee has the authority to correct a violation of this AKC Rule.

### **RV PARKING**

Daily rental rates are \$45 for 30 AMP or \$55 for 50 AMP. All sites come with water and sewer or a free honey wagon service provided through the fairgrounds. NOTE: You do not get to pick your location with regular RV parking. **Upgraded PREMIUM RV** sites are available, choose your exact location close to all the action for a one time up charge plus the daily rental fee from the fairgrounds. Your spot will be marked with your name or kennel name on an adorable garden flag with the DCA 2024 National logo or performance logo. A one time up charge of \$30 or \$75 plus the daily rental rate to the fairgrounds is required.
