## DOGS ELIGIBLE TO ENTER

These trials are open to all dogs (June 16 and June 17) and to all Dalmatians (all days) fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations, it includes both sexes. Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under four months of age are strictly prohibited from the trial grounds.

## MEASURING AND HEIGHT CARD INFORMATION

All dogs without a permanent or temporary height card will have to be measured by the judge before running. However, if a **Volunteer Measuring Official (VMO)** or an **Agility Field Rep** is present; ALL dogs without a valid Jump Height Card/Form must be measured at some time during the trial or cluster of trials. Height cards are not required to be submitted to the trial secretary; however, all exhibitors should carry the original AKC official jump height card with them to each trial in order to present the card upon request. When filling out the entry form, there is a section on the form for exhibitors to designate whether your dog needs to be officially measured. Please check the appropriate box so that the Trial Secretary knows whether to include your dog on the *Dogs To Be Measured List*. It is no longer required that you submit a copy of your dog's jump height card with your entry form or show it during day of show check-in.

## OBSTACLES AND RING CONDITIONS

Obstacles will meet the specifications for obstacles in the current edition of the Regulations for Agility Trials. All classes will take place indoors on Sports turf. Ring size will be 90' X 110'. Electronic timers will be used. Equipment will be provided by Purina Farms

## WAIT LIST FOR WITHDRAWN ENTRIES

DCA is offering a wait list to fill openings created by withdrawn entries after the trial's closing date/time.

A maximum of 20 entries will be placed on the club's wait list per trial. All entries, including waitlisted entries, must be received by the Trial Secretary prior to closing May 14, at 5 PM EDT. Any entries wishing to be withdrawn that are requested by Monday, June 9, at 6PM EDT will be replaced by a waitlisted entry if any are available. If a withdrawn entry is replaced by a waitlisted entry, a full refund will be issued for the withdrawn entry. Any waitlisted entry that does not move off the wait list into the trial by Monday, June 9 at 6 PM will receive a full refund. (We will destroy the entry and the check.)

## COURSE WALK-THROUGHS AND WARM-UP

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. Handlers with multiple dogs, at events with multiple rings may request to walk with a height group other than the one their dog is entered in if a conflict is imminent. A warm-up area, consisting of a regulation agility jump, may be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

## CLASS CHANGES EFFECTIVE JANUARY 1, 2020

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend -Multiple Jump Heights Within the Same Trial Day: Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. For example, the same dog may now be entered in Regular FAST and/or T2B to finish up those titles while also entered in Preferred Master STD/JWW to start working towards their PACH at the lower height. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day. Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day. A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend. When calculating entry fees, treat multiple entry forms for the same dog as if only one form had been filled out. In other words, the 1st run entry fee is only paid once per day, per dog, even if that dog's runs have been submitted on multiple entry forms.

## **Entering For Exhibition Only (FEO):**

- For Exhibition Only may be offered at the option of the host club. FEO will allow exhibitors to work with their dogs in a trial environment. FEO will be open for all classes. Participation in FEO is non-qualifying and will be marked in the catalog as "Absent".
- FEO runs are treated as trial entries. The exhibitor must enter the class(es) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (ex. when checking in at the gate board).

## Fix and Go On (FNG)

Fix and Go On (FNG): FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score. Fix and Go On is not pre-entered; rather, it occurs during the course of the run.

## CRATING

Limited crating space will be provided in the Great Hall near the rings ONLY for Agility, Obedience, Rally and Scent Work Exhibitors on the days of those events - Monday through Wednesday. Place crates ONLY on installed plastic. These crates MUST BE REMOVED AT THE CONCLUSION OF THESE EVENTS ON WEDNESDAY AFTERNOON.

- Excessive barking will not be tolerated. Crating is close to a ring, and it is not fair for barking dogs to interrupt judging or disturb the dogs in the ring. We will implement a three-strike rule, and all excessive barking dogs will be asked to be removed.
- Dogs may be left in the building until the conclusion of evening scheduled events.

## **PARKING**

- Exhibitor and visitor parking is located on blacktop parking lots in front of Purina Event Center.
- Vehicles are limited to ONE PARKING SPACE.
- No ex-pens or crates allowed on blacktop but are allowed on grass areas.
- No cones allowed in parking areas.
- NO PARKING IN ROADWAYS or next to building.
- ONLY cars with RV Parking Permits allowed in the RV lots.
- Please respect parking marked as reserved for judges, carpooling and handicapped spaces.
- Nestle-Purina Security will be in charge of all parking.

## NOTICE TO EXHIBITORS

- Bitches in season and injured dogs are not permitted to compete in Agility
   Trials. Entry fees will be refunded less a 5% processing fee per run entered with a
   certificate or letter from a veterinarian given to the Trial Secretary after closing
   and no later than one-half hour prior to the start of the first class of the day of the
   trial.
- Entry fee will not be refunded in the event that a dog is absent, disqualified, excused by the judge, or barred from competition by action of the Show Event Committee.
- · No entries will be accepted by phone or fax
- Changes, additions, or corrections to entry forms must be received in writing prior to the close of entries or as indicated in this document for move-ups. Those received by telephone are not acceptable.
- Please notify Trial Secretary of any change of address.
- No entry fees will be refunded if the Show cannot open or be completed by reason
  of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an
  act of God, public emergency, act of a public enemy, strikes, or any other cause
  beyond the control of the Club or the Trial Secretary.
- No entry shall be made, and no entry shall be accepted which specifies any condition as to its acceptance.
- Illegible entries will not be processed and will be returned to the exhibitor.
- Returned/Re-deposited/Post-dated checks do not constitute a valid entry.
- The trial secretary will add a \$25 collection fee to the amount of each returned/redeposited check.
- Exhibitors may wear shirts or insignia of their training group if they wish.
- THE AGILITY TRIAL COMMITTEE, THE DALMATIAN CLUB OF AMERICA, INC. SHOW EVENT COMMITTEE, AND THE SPECIALTY STEERING COMMITTEE CHAIRMAN may make and enforce any rules they deem necessary to ensure the continuity of the Agility Trial and the goodwill of the landowner.

- Anyone causing undue disturbance will be asked to leave the show grounds.
- DO NOT LEAVE DOGS IN CLOSED VEHICLES.
- Aisles must be kept open in the Grooming and Showing areas.
- Overnight Security will NOT be provided in the building.
- NO DOGS MAY REMAIN INSIDE THE BUILDING OVERNIGHT.
- No wagons, buggies, golf carts, skates, bicycles or scooters will be allowed inside the buildings.
- EXHIBITORS & GUESTS: No one is permitted anywhere that is marked "Employees Only" and/or "No Admittance." Violators will be reported to the AKC.
- No Smoking (including electronic cigarettes) in the buildings.
- No push pins, nails or any type of things going into the walls. No adhesive should be used to affix a sign to a wall.

- All dogs must be kept on leash except when being judged in off-leash events such as Agility, Barn Hunt, Dock Diving, Fast CAT, Obedience, Rally, Road Trial, and/or Scent Work.
- At no time can dogs be tied out or otherwise left attached to anything other than a human when outside a crate, car, or other secure enclosed confinement. Leashes cannot be left dangling or dragging. Standing or stepping on a leash is not allowed as a form of restraint (but may be used in an emergency to help secure a loose dog.) Accommodations to this rule may be made for differently-abled handlers as determined by the Club.
- The show site will be made available to exhibitors, SUNDAY, JUNE 15, 2025. The Great Hall is NOT AVAILABLE to EXHIBITORS BEFORE 4PM.
- No unentered dogs or puppies allowed in building per AKC guidelines.
- No working (practice) in rings before or after show hours. Dogs are allowed in rings only during judging hours and scheduled practice times.
- No crates at conformation ringside.
- Crates in the performance area of the Great Hall MUST BE REMOVED BY THE END OF THOSE EVENTS ON WEDNESDAY.
- No washing of animal food containers in restrooms.
- Bathing of dogs limited to bathing area in the Service Center. NOTE: The Service Center Building restrooms, showers and dog wash room will be off limits from 10AM-3PM on Monday and Tuesday to accommodate Scent Work Trial Classes. Please plan accordingly.
- Pick up after your dogs and dispose in provided receptacles.
- No videotaping or photography during the events for resale is permitted without the Dalmatian Club of America, Inc. approval.
- Please be advised: when an exhibitor/handler brings a dog to the podium for a win/placement
  photo they are establishing a de facto contract with the show photographer to purchase that
  photo.
- No baby strollers are allowed in the show site or adjacent hallways during show hours.
- Unless otherwise specified, all trophies and awards must be claimed the day of the show. **None will be mailed.** The club reserves the right to substitute a prize of equal or greater value.




# AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might
  reasonably appear that the judge's placements could be based on something other than
  the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- · Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- · Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

Dogs who measure into the 24" regular jump height division may not enter 24-choice. Dogs entered in the **Preferred** classes **must** compete at the requiredjump height and **may not** compete in a jump height division **higher or lower** than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine Partners<sup>SM</sup> program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.
